It is important that schools and parents work together to protect children and for us all to remember that safeguarding is everyone's responsibility.

Training

In addition to statutory safeguarding courses that Heads and senior staff members undertake, we also make sure that training occurs in our weekly staff meetings. Teachers are kept up to date with changes to key documents, they discuss different safeguarding scenarios to ensure that everyone would know what to do if they were concerned about a child and they learn about key strategies such as Prevent or Operation encompass. Even though Safeguarding cases may be infrequent, this 'little and often' approach to training ensures safeguarding is always high on the agenda and helps to prevent becoming complacent.

We have also recently undertaken Level 2 training for the many volunteers who come in to our school and also for our Governors. This training covers safeguarding procedures, scenarios and what happens when a referral is made to the Multi Agency safeguarding Hub (MASH).

Our lead safeguarding governors, Anna Neville and Yvonne Short, have both attended Level 3 training, which focuses on the specific responsibilities of key safeguarding personnel

Safeguarding Audits

All schools are required to complete an audit of their safeguarding systems and procedures, which helps us to identify our strengths and weaknesses. In addition to this, we have an external auditor come in and check everything from our site security to our record keeping.

All six schools have been audited in the last 12months and we continue to improve our systems and review our practice, so that we can be sure every one of our schools has safeguarding children as a key priority. The Executive Principal, Governors and Directors review all the audits and produce a Trust safeguarding action Plan which is then closely monitored.

One of the areas highlighted in several of our schools has been problems with car parking and traffic issues at the start and end of the day. Unfortunately the schools do not have adequate car-parking areas and with the narrow lanes there is a lot of congestion at peak times. We will be taking advice from Devon Highways and the local Community Police Officer, but in the meantime we politely request that parents park responsibly and take great care when driving near to the school.

Focus Item

Change for Life

Back in 2009, the government responded to the rise in obesity by setting up the Change4Life advertising campaign. Change4Life aims to prevent people from becoming overweight by encouraging them to 'eat well' and 'move more.' Latest guidance suggests that children should be active for 60 minutes a day and consume less than 25 grams or six teaspoons of added sugar per day.
